EXPLORATION UPDATE – AERIAL SURVEY

THE AERIAL SURVEY

Phase I of 3 is a passive aerial gravity survey. This means that there will be no impact to the land, animals or people. A plane will fly at about 500 feet with large distances between each path to take measurements.

The Airborne Gravity Gradiometer (AGG) measures small changes in gravity due to changes in the density of the rocks, which make up the Earth. This measurement makes it possible to remotely map the distribution of different rock types and the structure of the rocks. Both the AGG and Magnetometer are passive sensors, there is no active magnetic or electromagnetic emission.



Airborne surveys provide a non-invasive and economical way to acquire gravity data. Surveys which would take ground gravity crews many months or years to survey can be completed in days or weeks with an airborne survey.

Airborne surveys do not require land access and full data coverage is possible over the sea, lakes, rivers, forest, etc. This will help to provide more information on what may be located under the ground. This first phase will start in mid-May and last until about late June or early July 2020.

PROJECT IMPACTS

Short Term: There are little to no short term impacts. Once more information is learned about the survey, there will be additional discussions & meetings with communities on next steps.

Long Term: Limited opportunities up front for employment. Seismic & drilling may provide seasonal jobs. Discovery & development provide year round employment. Contractors are incentivized for local hire & business partnership.

Environmentally, each phase requires federal and state permitting. Cultural sites & traditional, local use are important to Doyon. All projects follow best management practices.
