Doyon is now accepting submissions for the Doyon, Limited Youth Holiday Artwork Contest. The artist who best depicts Doyon and its mission and values in a holiday-themed card will have their artwork published on Doyon’s 2023 holiday card, which is distributed to shareholders and friends of Doyon.

**To be eligible, the artist must:**

- Be a Doyon shareholder or direct descendant of shareholder, and between the ages of 5 to 17 years old on deadline date.
- Fill out and return this application with an authorizing parent/guardian signature with the artwork submission.

**Submission Requirements:**

- Artwork must be original.
- Submission should include a holiday theme and represent Doyon’s mission and values.
- Artwork may be painted, drawn or sketched by hand on letter size (8.5 inches by 11 inches) paper, photography or digital. Photo artwork entries must be submitted as a high-resolution JPEG with a minimum of 300 dpi. Digital artwork must be submitted as a PDF, with a minimum of 300 dpi.
- Doyon must receive all entries by 5 p.m. on Friday, October 20, 2023.

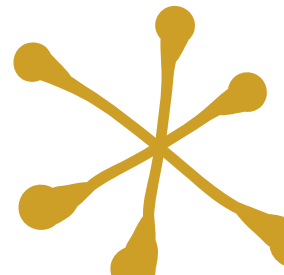

**OFFICIAL RULES**



1. General. The Doyon, Limited Holiday Card Artwork Contest

(“Contest”) is open only to Doyon shareholders or direct descendants of shareholders ages of 5 to 17 as of October 20, 2023. Winning is contingent upon compliance with these Official Rules, and conditioned upon completion of an affidavit of eligibility/liability and publicity release.

2. Duration: The Contest begins on September 21, 2023, at 9:00 a.m. AKDT and ends on October 20, 2023, at 5 p.m. AKDT .

3. Use of Submission: As the parent or legal guardian of a Contest participant, you, on behalf of the participant, grant Doyon an irrevocable, perpetual sub-licensable right to use the participant’s name, artwork, and any photos, videos or other content provided to Doyon as part of the Contest (collectively, the “Submission”), and to reproduce, modify, prepare derivative works of, distribute, and display the Submission in advertisements, promotional materials, publications, videos, websites, and other media now known or hereafter developed (collectively, “Doyon Media”). The Submission will not be returned to you and will become the property of Doyon. On behalf of the participant, you waive (a) participant’s rights of attribution, paternity, integrity, disclosure and withdrawal, (b) all rights participant may have under the Visual Artists Rights Act of 1990, as amended, or similar federal, state, foreign or international laws or treaties, and (c) all other rights throughout the world sometimes referred to as “moral rights.” You agree that this consent and release: (a) is given without coercion or duress; (b) is binding upon your heirs and future legal representatives; (c) is not limited to this contest, and the participant’s name and submission may be used in subsequent Doyon Media. Doyon is not obligated to use any submission.

4. Publicity: Acceptance of a prize or reward constitutes winner’s consent to Doyon’s and its agents’ use and publication of his or her name, likeness, biographical information, photograph, voice, opinions and hometown and state in any media for any commercial or promotional purpose, without further compensation or other consideration.

5. Warranty: You represent and warrant that the participant is the original creator of and has all right, title, and interest in and to the Submission.

6. Waiver: You waive any right to inspect, select, or approve Doyon’s use of the Submission. You agree to release, discharge, and hold harmless the Released Parties from any liability for alterations, distortions, or any other modifications, whether intentional or otherwise, of the Submission.

7. Selection of Potential Winners: Doyon will select notify the Contest Winner via telephone by Friday, October 22, 2021. Doyon’s decisions as to the administration and operation of the Contest and the selection of potential winners are final and binding in all matters related to the Contest. Doyon will select, in its sole discretion, one or more potential winners from the pool of entries, based on: (1) adherence to the stated artwork guidelines; (2) originality; and (3) overall impression of the entry.

8. Miscellaneous: Contest is sponsored by Doyon, Limited, 1 Doyon Place, Ste. 300, Fairbanks, Alaska 99701. Void where prohibited. Doyon reserves the right to cancel, terminate, modify or suspend the contest if necessary for any reason.
