Eligibility Criteria

- CHILD of an ORIGINAL* DOYON CLASS A, B, C, OR D shareholder and;
- ONE-QUARTER OR MORE ALASKA NATIVE blood quantum and;
- BORN AFTER DECEMBER 18, 1971.
- MAY NOT BE ENROLLED TO ANOTHER REGIONAL CORPORATION, ARCTIC VILLAGE, VENETIE, TETLIN, OR METLAKATLA

**Original shareholders received their shares directly from Doyon not through gifting or inheriting.*

Required Documents

- CLASS C APPLICATION -Application is available online at www.doyon.com
- ORIGINAL BIRTH CERTIFICATE – will be returned after enrollment

An original certified birth certificate is the only document that will be accepted. You can obtain an original birth certificate by contacting the Vital Statistics Office of the state where you were born.

Additional Documents, if applicable

- CERTIFICATE OF INDIAN BLOOD (CIB) – if biological parent(s) is Alaska Native, and not enrolled to Doyon, contact the Bureau of Indian Affairs at 101 12th Ave., Room 166, Fairbanks, AK 99701 or call toll free at (800) 822-3596 or in Fairbanks at (907) 456-0522.
- PROOF OF NAME CHANGE – if NAME is DIFFERENT than listed on birth certificate
- PROOF OF CUSTODIANSHIP – if not a biological or adoptive parent
- PATERNITY AFFIDAVIT – if father is not listed on child's birth certificate
- ADOPTION COURT ORDER – if adopted by one or both parents. Documents must show the biological parent(s) name(s). If your adoption court order does not show biological parents, contact Shareholder Records at 888-478-4755 ext. 2040 or in Fairbanks at 907-459-2040

Doyon CANNOT accept photocopies or notarized copies of birth certificates, birth certificates will be returned. If all required documents are not received the application will be returned. All personal information will be kept confidential.

TERMS, CONDITIONS, AND RESTRICTIONS

The following Terms, Conditions, and Restrictions are accepted by the enrollee or his/her custodian once the Class C stock is received:

- Class C stock is life estate stock which means upon death of the shareholder, the stock is cancelled without compensation to their estate or heirs.
- Class C stock and the right to receive dividends and distributions may not be sold, pledged, assigned in present or future, transferred by gift, even if restrictions on transfer end for Class A, B, C, D or E stock.
- Class C stock cannot be voted until the shareholder reaches the age of 18 unless Alaska law changes the age of majority.
- Class C shareholders may not now nor in the future own stock in another ANCSA regional corporation unless the other regional corporation stock is obtained by inheritance, gift, or purchase.
- Class C shareholders may not now nor in the future be enrolled to an "Ineligible Village" or Metlakatla. "Ineligible Village" means those villages within the Doyon Region (Tetlin Native Corp., Arctic Village, and Venetie) whose shareholders made the election under ANCSA to receive title to their reserve lands and relinquished the right to receive regional corporation stock. Native Village of Venetie Tribal Government (NVVTG) is the successor entity to Arctic Village and Venetie.
- Class C stock will be cancelled and will revert to Doyon without compensation if it is later determined that the recipient was not eligible to receive the stock or violates any condition for owning the stock.
- Shareholder agrees that if they make any misrepresentations regarding their eligibility for stock or violate any condition for holding the stock, then they will be responsible for repaying any dividends received.
